The <u>Civil Society Alliance</u> is a new project set up to empower civil society organisations from across the UK to scrutinise and influence constitutional, administrative and legal changes in the complex, multidimensional regulatory landscape following the UK's withdrawal from the European Union. The Civil Society Alliance is a member of the Civil Society Forum (CSF) established by the Withdrawal

Agreement.

The Civil Society Alliance has warned that the REUL Bill could have side-effects which will complicate resolution of issues around the NI Protocol - https://committees.parliament.uk/writtenevidence/113319/html/ Membership of the CSA is open to civil society organisations, and pro-EU organisations participating in the Round Table may be considering, or may wish to consider joining it and supporting its work.

National Security Bill.

Campaigners are concerned that the <u>National Security Bill</u> could require people and institutions to report on contacts with friendly state governments that might be seeking to influence the UK government whilst failing to address the influence of rich individuals or corporations.

Elections Act 2022.

Tom Brake, Director of <u>Unlock Democracy</u> writes: "the Elections Bill Coalition is being resurrected because of concerns over the poor implementation of the photo voter ID requirement, which could lead to unsafe elections".
